- 6) A copy of the stallion's breed registration papers showing current ownership must be included with the **NEW** stallion nomination.
- 7) Copy of registration papers are **NOT** required if ownership has **NOT** changed for **ANNUAL** stallion nomination.
- 8) Stallions must be re-nominated yearly to remain in the program at the current nomination fee.
- 9) Must be **nominated** and include **full payment** by **April 15th** of year prior to nomination.
- 10) Failure to meet the nomination deadline could result in the stallion being dropped from the program.
